3. DELEGATION REQUEST

General Nature/Purpose of the Delegation:

Mayor Lucas asked " Is there an incentive to reduce storm water, and if not why not?"

Purpose of this delegation is to show storm water management fees must offer financial incentives for all Cobourg residents and businesses to use low impact development on our properties, whether it's planting trees in the right places, using permeable pavers, or using rain barrels etc. effectively to reduce storm water

Cobourg is on 7 creek and Lake Ontario floodplains. Now is the time to protect our watershed from flooding. The federal government is set to release \$1.6 billion in climate resilience grants, including coastal grants.

If storm water management fees were to give financial credits for those with trees, rainbarrels etc, Cobourgers would have real reasons to learn and adapt to climate resilience. Philadelphia and Waterloo have credit offsite purchase programs and there are adaptations for smaller places like us. We need to look at their's and others' best practices.

I just attended Cobourg Sustainability's "Integrated Cobourg Sustainability plan" ICSP at Venture 13 this evening in which planner Anne Taylor Scott gave a presentation. Gigi Weaver read that "ICSP 'integrates low impact 'design principles into neighbourhood planning process.' Green Development Standard includes storm water management and water conservation. Anne explained that the ICSP and Green Development Standards will all be introduced in 2023.

So the ICSP and GDS can get the criteria for best practices for storm management fees in which we all save money. Even better, they can start to educate us how to do low impact development now. Let the rain fall, and nourish where we want it to. No flooding for Cobourg.
