# WHY AM I RUNNING?

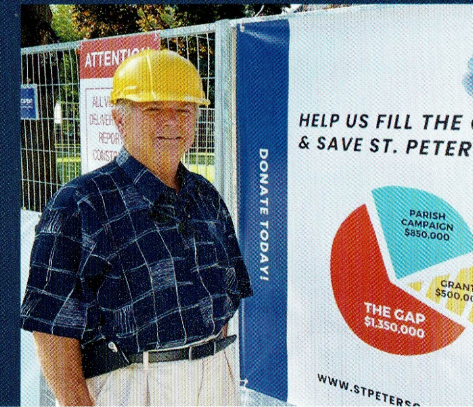
