Feb. 1, 2016 - CTA Delegation to Council on Proposal for Changes to Marina Policies

The Cobourg Taxpayers Association (CTA) believes that the Marina is a valuable asset to Cobourg. After considerable study, the CTA wishes to highlight a budget item which we feel is not essential and represents a very high cost. We also offer a financial plan for the Marina. <u>See the link to the delegation here.</u>

This unwarranted expenditure is listed in the Parks and Recreation Department Budget: as "Boat Handling Equip. & Compound Expansion". Essentially, this is a Travelift, haul-out slip and trailer to handle boat launch and haul-out at an estimated cost of \$687,000. No amounts are included for operator salary and benefits, operator training and maintenance of the equipment or possible dredging of the haul-out slip.

In addition to the information on the Travelift we have included an analysis of the fees and capacities of marinas in other nearby towns. The conclusion is that fees in Cobourg are lower than most competing communities so they could easily be raised to help ensure a sustainable facility.

The CTA, in the following study, has suggested a number of ways that this can be achieved.


We feel confident that with the skill and co-operation of Councillors and staff directors this can be accomplished.

The CTA hopes that you enjoy our first annual report card for our councillors. The idea was created in response to the report card done by the <u>Northumberland News on June 25, 2015</u>. We thought it was sadly out of touch and decided to do our own. Ratings from the CTA's six directors were collected, compiled and consolidated. We also compiled a chart based on our supporters' ratings. You can view it from <u>here</u>.

Debra McCarthy and Theresa Rickerby are carrying about double the number of committees as the Brian Darling, Forrest Rowden and Larry Sherwin (8 vs. 4). In addition, their committees tend to be more labour-intensive and somewhat controversial. Link to councillor responsibilities here. The Study In Brief

In nearly all Canada's major cities, what should be a simple exercise – comparing the spending voted by city council in its annual budget with the actual spending reported at year-end will baffle any but the most expert reader. While most of Canada's federal and provincial governments now present their budgets on the same basis as their financial reports, municipal governments typically do not. As a result, judging whether a city over- or under-shot its budget targets, and by how much – which should be a simple matter of comparing headline numbers – is not possible for a typical councillor, taxpayer or citizen.
