For residential taxpayers in Cobourg, this year's tax rate of .0090535 represents a 2.22% decrease from the 2008 tax rate.

The effect of this increase is set out below. There is also a comparison of your 2008 and 2009 tax bills on Schedule 2 of your bill.



Finance / Tax Office Moves to West Wing

Recent months have seen some big changes in the daily activities within Victoria Hall. As of November 30, 2008, the Courts have consolidated all of their operations at 860 William Street, the former County of Northumberland building.

The space formerly occupied by the Courts on the main floor west wing of Victoria Hall is now the new location of the Finance / Tax department. This move allows for all finance department staff to be located within the same office, something that has not been the case for many years.

Effective May 1, 2009, if you are coming into Victoria Hall to pay taxes, parking tickets or to purchase garbage bag tags, dog tags, parking passes or transit tickets, please proceed to your right after entering the front doors of Victoria Hall and you will arrive at our new location in the west wing.

In addition, a new exterior drop box has been installed on the Third Street side of Victoria Hall if you are dropping off items for Finance / Tax department. All other contact information remains unchanged.

All other administrative services will continue to be located in the existing Municipal office on the main floor east wing of Victoria Hall including the offices of the Mayor and CAO as well as the Clerk's department and Human Resources.

We encourage all members of the public to come in and see us in our new location.
