For residential taxpayers in Cobourg, this year's tax rate of .0084576 represents a very slight decrease from the 2014 tax rate.

The impact of this decrease coupled with an average .47% assessment increase is set out below. There is also a comparison of your 2014 and 2015 tax bills on Schedule 2 of your bill.


